FULBRIGHT FRANCE POSTGRADUATE STUDENT AWARD IN LAW AT THE UNIVERSITY OF PENNSYLVANIA CAREY LAW SCHOOL

The University of Pennsylvania Carey Law School has partnered with Fulbright France to offer funding for eligible students to pursue the LLM degree at Penn Carey Law in Philadelphia.

Eligibility Eligible students must be a citizen of France, and must hold a first degree in law from a foreign (non-U.S.) jurisdiction. Dual Franco-American citizens are not eligible. Candidates already residing or studying in the United States are not eligible.

Program The University of Pennsylvania Law School grants a generalized LLM, allowing foreign trained attorneys to design their own curriculum. You'll have the opportunity to take charge of your education and select courses from the extensive curriculum offered at Penn Carey Law as you see fit. As an LLM student, you'll join upper-level JD students in our advanced courses. Our program is ten months and includes a mandatory five-week Pre-Term Program.

Penn Carey Law LLM students are also eligible to enroll in the Wharton Business and Law Certificate, a custom designed program only for our LLM students. You'll experience Penn's cross disciplinary curriculum firsthand and learn from Wharton faculty and industry experts who offer applied concepts and real-life examples. All LLM students may participate in this program which runs concurrently with the LLM program. (There is an additional fee, not covered by the scholarship.)

Penn Carey Law LLMs gain real world US legal experience: The LLM Public Service Program presents you with opportunities to develop your professional skills and learn more about the communities that exist beyond Penn's Law School. The program also supports students seeking to satisfy the New York Bar pro bono requirement. LLM students have also participated in clinical programs focusing on Entrepreneurship, Intellectual Property and Technology, International Human Rights and Immigration, and Mediation.

Penn Carey Law LLMs also get involved with JDs in student groups ranging from the Law School Light Opera Company to the Penn Soccer Club. LLMs often participate in student run journals. In the past that has included the Journal of International Law, The Asian Law Review, and Journal for Law and Social Change.

Grant Fulbright grantees are eligible for a \$35,000 scholarship. Additional outstanding candidates referred by Fulbright France to Penn Carey Law will also be considered for funding.

Fulbright grantees will also be provided with a travel stipend of 1,200€, health insurance, J-1 visa sponsorship, and access to global Fulbright programming in France and the United States. A maintenance grant may also be offered.
